SUBJECT: Cancellation of (NLEECX)

2020 National Law Enforcement Exploring Conference Xperience

After weeks of analyzing the current pandemic situation within the United States and attempting to devise alternate plans, the National Law Enforcement Exploring Committee has determined that we are unable to hold the 2020 National Law Enforcement Exploring Conference Xperience at the Summit Bechtel Reserve in West Virginia.

The Committee consulted with federal, state and local health agencies to determine if the conference could be held safely and at a level of professionalism that we demand of our program. Additionally, we spoke to numerous members and cannot dismiss the toll COVID-19 has taken on families. The Committee even pursued multiple options to hold a modified Conference with the intent of an event to help alleviate the stresses that this situation has brought about to everyone, especially those in the public safety sector. Unfortunately, we were unable to identify a safe plan in which to do so.

Posts that have already paid their 2020 NLEECX deposits will be offered a full refund or an option for the National Learning for Life/Exploring Service Center to reserve their deposits for the rescheduled conference. The National Service Center will be sending an individual message to each of the currently registered Posts, explaining these available options.

While we may be unable to convene at the 2020 Conference, the National Law Enforcement Exploring Committee has many important opportunities planned for the next 24 months:

# May to December 2020

• Finalize the Concept of Operations plan and Standard Operating Procedures for the program, as well as events (i.e. Academies, Conferences, etc.). This effort will serve as the needed blueprint and promulgating documents for the long-term sustainability of the program, as well as future conferences. In short, this will be the Law Enforcement Exploring Handbook for Operations.

- Online National Law Enforcement Exploring Youth Representative Elections
- Exploring USA Video Submission Competition
- Virtual Law Enforcement Exploring 5K
- National Virtual Post Talent Show

#### Winter 2020

• The Committee has not ruled out holding the Conference in 2021. Venue selection, COVID-19 status and interest will be vetted in the coming months. Additionally, planning and possible expansion of events usually occurring in the "conference off year" will occur.

- National Conference (Rescheduled, if possible, with input from Associations and Posts)
- National Leadership Academies
- Assembling a contingent of Law Enforcement Explorers to the 2021 National BSA Jamboree
